Subject: Aadhaar Seeding with Bank Account for Enabling DBT Payment of Post-Matric Scholarship (CSS) for ST Students for the AY/FY 2025-26.

It is hereby informed to all concerned that the disbursement of the Post-Matric Scholarship for Scheduled Tribe (ST) students for the Academic/ Financial Year (AY/FY) 2025-26 commenced in March 2026. However, the beneficiary status of **891 students (FRESH: 801 nos., and, RENEWAL: 90 nos.)** has been rejected due to the reasons "**UID NEVER ENABLED FOR DBT**" and "**UID DISABLED FOR DBT.**"

2. Accordingly, all affected students are requested to contact their banks to seed Aadhaar number with their bank account in order to receive Aadhaar-based scholarship payments.
3. In addition, the National Payments Corporation of India (NPCI) has launched the Bharat Aadhaar Seeding Enabler (BASE) platform, which facilitates Aadhaar seeding and de-seeding activities in a self-service mode for Direct Benefit Transfer (DBT). This platform is available on the National Scholarship Portal (NSP) under the "Student Announcement" section at the following link: <https://scholarships.gov.in/student-announcements>
4. Students listed in Annexure-I are requested to complete the necessary actions by **5th May, 2026**, repeat, **5th May, 2026**, without fail. Students are also advised to verify the Aadhaar and bank account seeding/ mapping status by visiting the websites: <https://www.npci.org.in/>

6. This notification must be disseminated to all concerned students by the respective Institute Nodal Officers (INOs), Heads of Institutions (HoIs), District Education Officers (DEOs), District Welfare Officers (DWOs), and Sub-Divisional Welfare Officers (SDWOs).
